Orora Limited today announced the official opening of its purpose-built facility at Bundaberg, in partnership with AHG Refrigerated Logistics. The opening was marked by the unveiling of a plaque by Orora Managing Director and CEO, Mr Nigel Garrard and AHG CEO of Logistics, Mr Stephen Cleary, at an event attended by V8 Supercar champion, Scott McLaughlin, customers and local dignitaries.

The new 4200 square metre corrugated packaging, cold storage and transport facility will provide significant long-term benefits to Orora's fruit and produce corrugated customer base in Bundaberg. The additional refrigerated transport resources provided by AHG means Orora can provide an end-to-end packaging solution for its customers, bringing their produce from farm to market in pristine condition.

Orora will continue to focus on its core strength, providing cost-effective, fit-for-purpose, corrugated cartons for the Bundaberg fruit and produce region and through its strategic partnership with AHG, customers will be provided with comprehensive logistics infrastructure that will deliver corrugated cartons to them in a timely manner.
